- The group will be judged on 7 criteria (i.e. vocal quality, diction, song choice, stage presence, etc.) by a group of pre-selected local community members.
- The top winning ADULT and top winning YOUTH group will each receive a \$200 award and the remaining caroling groups will also win a cash prize. That's right, EVERYBODY WINS!
